

NON-JPL AUTHOR LICENSE TO PUBLISH AND CERTIFICATION OF CLEARANCE

Furthermore, the author or author's organization's authorized representative must grant the Jet Propulsion Laboratory, California Institute of Technology, a non-exclusive license to publish the contribution. Granting such a license does not preclude the author from using his or her work elsewhere.
